The Electoral Commission of the SRC warmly extends greetings to the student body. In line with our constitutional mandate and commitment to transparency, we are pleased to officially declare the results of the 2026 SRC General elections which was conducted on the 30th of April,2026. The following reflects the collective choice of students as expressed through the ballot. Following a transparent and credible electoral process, the Commission presents the final outcomes with percentage distributions as follows:

1. SRC TREASURER

Total Votes Cast (Valid + Invalid): 776

YES Votes: 668 (86.08%)

NO Votes: 95 (12.24%)

Rejected Votes: 13 (1.68%)

Decision:

The "YES" votes having secured an overwhelming majority of 86.08%, the nominee for the position of SRC Treasurer, in the person of Mr. Ernest Teye is hereby APPROVED.
